As stated in **Section 5 of the By-Laws: The Board of Governors shall elect from its members a President, Vice-President and Secretary—Clerk. Reference Section 4 of the Charter.**

BY-LAWS of THE PROPERTY OWNERS' ASSOCIATION OF LAKE HAYWARD (POALH) ARTICLE V

BOARD OF GOVERNORS

Section 1. The members of said Association shall elect from said members, a Board of Governors consisting of nine members as follows:

- (a) Three for the term of one year each, one member from each district;
- (b) Three for the term of two years each, one member from each district;
- (c) Three members at large, one for the term of one year, one for the term of two years and one for the term of three years. Reference Section 4 of the Charter.

Based upon Article V of the By-Laws, the committee would also like to propose the re-election of the remaining current members to the Board of Governors with the following district representation and terms:

Members at Large:

Robyn Constable – for the term of 2 years

Jeff Walter – for the term of 1 year

Members to represent the Third District:

John Jacoby – for the term of 2 years

Cindy Biancamano – for the term of 1 year

Members to represent the Second District:

Ray Brignano – for the term of 2 years

Vicki McDonald – for the term of 1 year

Members to represent the First District:

Rich Harmon – for the term of 2 years

Alice Miles – for the term of 1 year
